 A paralegal is a community based person trained with basic knowledge of the law and the legal procedures to enable them enlighten members of the community and also act as first responders to cases of Gender based violence.
- 2. What is Alternative Dispute Resolution? Alternative Dispute Resolution is a means of settling disputes outside the courtroom.
- 3. What is Human Right?
 Human Rights are rights inherent to all human beings, regardless of race, sex, nationality, ethnicity, language, religion, origin, colour, language or any other status.
- 4. What is Gender?
 Gender is the full range of personality traits, attitudes, feelings, value, behaviors and roles played in the society by both sexes (male & female).
- 5. What is Gender Based Violence?
 Gender-based violence is any form of physical, verbal, emotional, economic or social

- 6. How can I get to know about Gender Based Violence cases?
 - · If you experience any form of violence.
 - · If a survivor discloses acts of violence to you or a non-governmental organization.
 - · If a party that has knowledge of an incident or incidents discloses them to you.
 - · If a caretaker/relative/parent/guardian of a survivor discloses such acts to you.
 - · If a health provider discloses such cases of violence to you.
 - · You become aware of reports in the media.
- 7. What to do when your right is violated. Report the matter immediately to:
 - i. Paralegals.
 - ii. Police officers
 - iii. FIDA
 - iv. Welfare officers.
 - v. Traditional/Community leaders.

- 8. Role of Paralegals.
 - a. Inform the survivor of the options of having a person with whom he or she is comfortable in the room during the interview.
 - b. Explain the support services available to the survivor.
 - c. Get the survivors informed consent before providing legal services.
- 9. Role of FIDA.
 - i. Inform survivor of all legal aid support options available to them.
 - ii. Assist to file complaint.
 - iii. Arrange transportation to hospital where treatment is needed.
 - iv. Explain rights to protection and remedies under the relevant laws.
 - v. Explain right to lodge criminal complaint.
 - vi. Facilitate the arrest of the perpetrator.
 - vii. Ensure safety and wellbeing of complainant/victim.
