FIDA Nigeria is a voluntary association of women called to the practice of law in Nigeria with over 4,000 members in 43 branches across the 36 states of the Federation.

With a mandate to promote, protect and preserve the rights, interests, and wellbeing of women and children through the use of a legal framework to ensure that they live free from all forms of discrimination, violence, and abuse in society, and to also pursue a just, peaceful and equitable Nigerian society where women and children's rights, interests are guaranteed, including the freedom to choose and live their future

To promote the principles and aims of the United Nations in their legal and social aspects

To promote the study of comparative Law

Highlights of a Tenure of Quantum Leaps

One of the biggest leaps which included innovations and resulted in great accomplishment was the bold step taken towards fundraising to acquire and furnish a duplex in a prime location to serve as the FIDA National Secretariat and be known as the FIDA Nigeria House.

Another leap was the Inauguration of new FIDA Branches particularly multiple branches within a state

This was necessitated by FIDA's drive to bring its services closer to the grassroots due to high demands from communities, partners and members alike with the resultant effect of a greatly increased membership base

We celebrate today the inauguration of the underlisted new branches:

Bauchi, Zamfara, Warri, Gwagwalada, Zaria, Ikorodu, Badagry, Katsina, and Eket.

Another leap was the Launch of FIDA Nigeria Data Collection Website enabling accessibility and modern data collation of all matters handled by FIDA Branches

Furthermore, was the Review of the FIDA Nigeria five-year Strategic Plan 2015 – 2020 and the production of

the revised Strategic Plan for the period 2021 – 2026.

Additionally, FIDA supported women/ children's wards in government owned hospitals were adopted by key FIDA branches namely- FIDA Anambra, FIDA Kogi and FIDA Cross-Rivers

Most importantly, FIDA Nigeria conceptualized and successfully implemented a Self-funded Paralegal Training Project foccused on supporting her branches across the federation to organize training for paralegals. Following which a total of 29 states branches carried out training in at least 110 communities in 55 local government areas. These paralegals were trained as first-hand responders to cases of SGBV and harmful practices that affect the rights and wellbeing of women and children in Nigeria, thereby greatly improving access to justice

They were formally inaugurated following their oath of office













Education As a Right, The Challenges Against Its Enjoyment - BY ADEJOKE LAYI-BABATUNDE

INTRODUCTION:

"Education is the most powerful weapon which you can use to change the world". This wise quote from one of the most influential leaders of our time, late President Nelson Mandela sums it all up.

Education is indeed a weapon, a tool, and an instrument for change in any society. It is certainly a Catalyst... Whether male or female, Education like knowledge is power and allows for selfactualization, preservation; improvement, good character, and learning which in turn paves the way for a better society.

EDUCATION AS A RIGHT

Education is not a privilege. Edu-

of school for social, economic, and cultural reasons. Mr. Peter Hawkins the UNICEF Representative in Nigeria during the 2022 International Day of Education stated that "10.5 million children are out of school in Nigeria, which is the highest rate in the world. The figure indicates that one-third of Nigerian children are not in school, and one in five out-ofschool children in the world is a Nigerian." UNICEF report revealed that some children are more likely to be affected than others - girls, children with disabilities, children from the poorest households, in street situations, or affected by displacement or emergencies, and

cation as a right of every human means that; it is legally guaranteed for all without discrimination and states are entrusted with preserving and protecting this right for every child.

The Universal Declaration on Human Rights, adopted in 1948, proclaims in Article 26: ' everyone has the right to education.

The right to education has also been reaffirmed in other treaties covering specific groups (women and girls, persons with disabilities, migrants, refugees, Indigenous Peoples, etc.) and contexts (education during armed conflicts).

However, the UNESCO report indicates that 258 million children and youth worldwide are still out

children in geographically distant areas are all disproportionately affected by the education crisis.

CHALLENGES TO THE ENJOYMENT OF THE RIGHT TO EDUCATION IN NIGERIA

Gender Discrimination

It is a fact that there is inequality in educational chances and accomplishments (a disparity in opportunities) between males and females in Nigeria. And this inequality is founded on several factors which include family background, socioeconomic factors, and so on. The division of members by societies into two classes while ascribing them with different roles is referred to as Gender.

This division is the conception of gender inequality.

Culturally, males are respected as being special to females. Iloegbunam in his publication; "Rights of women as panacea for repositioning women education in Nigeria." notes that: One of the ironies of history is the fact that despite the roles women play both at home and the society, they have remained unnoticed and even belittled. This is borne out of the wrong notion that women's education ends in the kitchen, childbearing and caring. Therefore, women are believed only to be seen and not heard.

Research conducted by Omoregie and Ihensekhien observed that this discrimination against women "has grossly affected female enrolment in education, especially in the Northern region of Nigeria."

• Children With Disability Due to inadequate good health care, a vast proportion of children with disabilities in the world live in developing countries. A 2017 World Bank Study indicated that the literacy gap between CWDs and their able-bodied counterparts has been on the increase over the last 3 decades. This effect is based on various circumstances which include marginalization, segregation, and discrimination. In Nigeria, CWDs face several challenges in actualizing their right to education. The first challenge is the unfavorable cultural notion that exists about disability as well as several other challenges. Disability is viewed as a curse amongst many cultures in Nigeria. Other negative cultural perceptions exist about disability. Name tagging people with disability creates harsh barriers to them from a cultural, social,

and economic perspective; this imposed limitation that isolates them from the culture and the society (Eskay et al., 2012).

Nigerian Child's Right Act 2003 has provided substantial stands for the rights of a child. Section 16 (1) of the Act ensures that any child in need of protective measures shall be entitled to a measure of protection adequate to their needs in furtherance of their active involvement in the community. However, section 16 of this provision restricts the enjoyment of the rights of children with disabilities to the availability of resources and at the discretion

of their caregivers.

The public educational institutions are designed for able-bodied children without consideration to CWDs. This leaves CWDs perpetually dependent on others for support, hence demoralizing their confidence.

Insecurity

From report made available by UNICEF; In 2021, there were 25 attacks on schools. 1,440 children were abducted, and 16 children killed. In March 2021, no fewer than 618 schools were closed in six northern states (Sokoto, Zamfara, Kano, Katsina, Niger, and Yobe) over the fear of attack and abduction of pupils and members of staff. The closure of schools in these states significantly contributed to learning losses for over two months." Insecurity is now a bane to uninterrupted education in the northern part of Nigeria.

Poverty

Poverty occurs when the citizens lack access to basic needs in life such as shelter, food, and clothes. The National Bureau of Statistics (NBS) released its report which shows that 82.9 million representing 40.1 percent of Nigerians are poor. Poor minds have no time for education.

Poverty is one of the greatest threats to increased quality education in any given country. The National Policy on Education (1981) prescribes a hundred percent transition rate from primary to secondary schools, but we are yet to achieve this as a nation. And in States where primary education is technically free, extra charges for uniforms, textbooks and transport fares to schools forge financial barriers for many parents. Many poor parents claim that the indirect costs are a challenge to sending their children to school.45% of our girls are married off before the age of 18 years increasing the number of Sexual and Gender Based Violence (SGBV)

SOLUTIONS TO THE CHAL-LENGES RAISED AND CONCLU-SION

1. The relegation of the role of women to childbearing and domestic chores does not fit the modern practice in the civilized world. All effort to put a stop to the trend must be engaged. Child labour must be discouraged.

2. There should be implementation of laws to help children with disability access quality education better.

3. The government at all levels should declare a state of emergency on insecurity. Education will be difficult to propagate in an insecure society.

4. Government should take up the responsibilities of catering for the textbooks, and school uniforms needs of students to compensate for free education. Also, more classrooms should be built to reduce overcrowding among students.

5. Adopting Technology to spreading quality education is recommended. The recent pandemic has revealed the great potential that lies in the virtual class. Technology can complement the physical classroom teachings. Infact, with the COVID 19 pandemic that engulfed the world in 2022 when Life as well as Schooling moved online, it's very certain that we must embrace the benefits of leveraging on Technology.

It is also advisable that School Curriculum must be revised to accommodate the changes that have taken place in our world this Century and Teachers, Counselors, Care givers must be trained continuously so that they are able to give their best. Their Financial Situation should be looked into

also. It is one of the reasons why ASUU has been on strike and our" Leaders of tomorrow "are left Confused and uncared for increasing Crime rate in the society.

Education is key to the development of any nation and striving towards making quality education available is a sure way of securing and empowering the future of the country. The Government, Ministry of Education, NGOs, CSOs, First Ladies of States, Ministry of Budget, National assembly et al must rise up to this Occasion and Salvage EDUCATION.

SECOND QUARTER NEC MEETING

Day 1: FIDA Nigeria as part of her 2nd Quarter National Executive Council Meeting Activities which held in Bauchi was hosted by her Bauchi State Branch, ably led by the Chairperson Fatima Abubakar.

The line-up of activities commenced on Tuesday, the 21st of June 2022 with an outreach to the Bauchi State Correctional Centre where FIDA working in collaboration with her partners namely, Al-Muhibbah Foundation, Nigerian Association of Women Journalists (NAWOJ), Selfdiscovery Empowerment Foundation, Medical Women Association of Nigeria Bauchi and Attah Sisters Helping Hands Foundation visited the Bauchi Custodial Centre.

Legal Clinics were held where cases of inmates were taken, psychosocial support and medical aid was also given particularly for the female inmates.

The First Lady of Bauchi State (Dr) Aisha Bala Mohammed, Founder of Al-Muhibbah Foundation, being most passionate about support to the less privileged in our society was present with a large entourage which included the Deputy Governor's wife Hajiya Aishatu Alhaji Baba Tela and wife of the SSG Hajiya Habiba Ibrahim Kasim.

Words of encouragement and prayers were offered while necessary items such as toiletries and other materials were donated.

We ensured the release of some inmates by the payment of fines, fulfilment of bail conditions and so forth

At the end of the outreach, inmates expressed immense gratitude for the interventions while airing out on some of the challenges they faced with the legal processes/ system, the available infrastructure and inadequate facilities of the prison service.

The National Executive Team made a special appearance by



attending the Specialized Capacity Building Workshop for Judges, Judicial & Legal Officers on Countering Trafficking in Persons (Northern Nigeria) which was organized by FIDA Nigeria in Bauchi State under the Palladium's Scale Project.



Active Participation of Women in Politics

By Rhoda Prevail Tyoden

Rhoda Prevail Tyoden, Past National President of the International Federation of Women Layers, FIDA, Nigeria Chapter speaks on the case for women in politics and public offices, Accountability and other related matters in an interview with Taiwo Adeleye of Women Radio.

Why is there a need to push Towards Inclusive Governance in Nigeria (TGIN)?

ANSWER— Statistics of women participation in politics depends on what you are looking at. I believe that there are different variables that make up politics, from being a party member, voting at elections, vying and contesting for an elective position to being elected to elective position and also getting appointed into a public office etc

Women all over Nigeria participate in politics, they are into campaigns, they come out en masse to vote. In all these, you can say that they participate but when it comes to vying for elective positions and appointment to public offices, they are grossly underrepresented. Under the current dispensation, women are said to be representing 4.7% of the total elective position, which is not right for true democracy. It is a situation of 50% of the population not being their when decisions that affect them is being taken which is contrary to the principle of equity and an egalitarian society.

Question: What are your thoughts on the statement made by the Senate President Ahmad Lawan on the International Women's Day?

ANSWER — It is good that the constitution is being amended, this is long overdue. The Senate President has spoken and as a distinguished man that he is, we want to trust him to deliver on his words. It doesn't matter what the senate has not done in the past on this same matter. For what we have now is what they have said, and we trust them to match action with words.

Women of Nigeria are watching, and these women comprise of their colleagues in the National Assembly, their mothers, wives, sisters, daughters and granddaughters. The World is a global village and for any nation to develop and be healthy, there must be gender parity in public life. The need for the amendment of the constitution cannot therefore be overemphasized.

Question: How do you think women should react to this

statement?

ANSWER- To hold government accountable, we must continue to demand for accountability in all ramifications. That is why the Nigerian women are demanding for the amendment of the Constitution to address the continuous discrimination and violation of women's rights both in private and in public life.

The Women groups in Nigeria through the Incorporated Trustees of the National Women's Trust Fund have gone to court to challenge the poor implementation of the 35% Affirmative Action and the violation of the National Gender Policy 2006 which was instituted after affirming the Beijing Platform for Action of 1995 by the Nigerian government.

They are also seeking for the interpretation of the provisions of our constitution which prohibits all forms of discrimination (such sections as 42, 147, 14 (2) and the provisions of many international instruments of which Nigeria ratified and is a signatory to. **Question:** Why are female Political aspirants measured on a different yardstick?

ANSWER-The women in the western world that are holding great political positions are women like the women in Nigeria, they do not have 2 heads, but the difference is in the enabling environment which allows them to engage meaningfully without any form of discrimination. Their election and electoral processes are devoid of any form of violence, high monetisation and intimidation. Their laws are sacrosanct and respecter of no man. Rule of law is entrenched. Their political stage is a flat stage for all.

Talking about the Tanzanian Woman President, I'm happy for her and I also sympathize with the family of the Late President. It is not our wish and desire that a President has to die for a woman to ascend to that position. Women are qualified to be so elected and should be given the opportunity without any bias or unequal treatment. There are countless women that meet the qualifications and criteria for the office of the President. All we need is the enabled environment that is free and fair without any inhibitions or limitations. Nigerian women are great leaders with evidence all over the globe showing the stuff

they are made of in their respective offices. Asking whether Nigeria has developed to the extent of having a female President is uncalled for.

Question: How would you encourage women to participate and make a change for 2023 election?

ANSWER—Getting more women to participate in politics is not rocket science. With what we are seeing, hearing from the government, I believe that the needful is being addressed which includes but not limited to the following:

Amending the Nigerian Constitution that will promote gender parity in all spheres of public life
Calling for the implementation of the provisions of the National Gender Policy which is in tandem with the declarations of

 Create an enabling environment that is devoid of any form of discrimination and violations of women rights which are human rights.

• Political party constitution should be gender neutral

• Government should implement the recommendations of the Electoral Reform Committees (Justice Uwais Committee) which was holistic in approach.

• Support the bill that seeks to

make it mandatory for a quota system allocation of seats to women in every state.

 empowerment of women to enable them to compete favourably. We must note that majority of women are in unpaid care jobs with little or no income, which limits the resources at their disposal, it also affects the time they may have to participate in politics.

 Government should invest more in public facilities/ infrastructure which will help reduce the time and energy the woman expends in her unpaid care job.

 Our laws should be gender neutral and government should take proactive measures to ensure for effective implementation of our national laws, and all international instruments that Nigeria is a signatory to.

• Women should continue to build coalitions nationwide, in all communities to sensitise and create awareness on the need to participate in politics.

 Men should see women as partners and not competitors, let's team up to build back a better Nigeria.

Work with Gate Keepers including Women Leaders, Youths, Religious Leaders and Traditional Rulers to Address Social Norms that negatively affect the status of Women and entrench violence against women and girls



Our focus is targeted at Identifying and Disrupting Societal Norms that Subjugate Women and Girls through a community led approach.

Working on this, FIDA Nigeria has developed the capacities of community stakeholders with particular attention to women on issues of gender-based violence, promotion of women's rights and instilling leadership abilities in community women leaders across six beneficiary communities namely (Obadore & Odongunyan/Odonla Communities) of Lagos State, (Bukuru Gyel & Mangun Communities of Plateau State, Erinmope-Ekiti and (Ilawe-Ekiti Communities of Ekiti States respectively

Project Supported by Ford Foundation for a period of Two years (June 2020- September 2022) in Ekiti, Lagos & Plateau States.



Activities conducted that yielded great success includes the following:

Mapping and scoping of activities with inception meetings.

The holding of two capacity building sessions on:

a. Elimination of Sexual and Gender Based Violence through the effective implementation of the VAPP Act/Law and other related laws across the States, and

b. Enhancing leadership abilities in community women.

To drive home salient points, we held necessary Media cam-

paigns and awareness activities on GBV and socio-cultural norms that negatively affect the status of women and girls.

In conclusion of which an Annual Dialogue and Award Event was held in 2021 to promote peer learning approaches on altering negative social norms subjugating the rights of women and girls prevalent across the six communities.

However, for sustainability purposes the following additional

activities will be implemented from Last week of June – August 2022

Training of FIDA State Branches on effective best practices in sustaining the interventions after the project tenure.

Unscheduled Visitations to focal Community visitations to review implementation process of Action Plan.

Training and retraining of community paralegals and surveillance team on effective reportage and case management skills.

Community awareness campaigns/ rallies in focal communities on GBV sensitization/ action plans

Annual peer-learning system/ Dialogue Sensitisation Campaigns on Community action plans.

Major challenges experienced in our implementation process are:

The constant security concerns around Plateau and Ekiti States which has in some ways hindered progressive monitoring and implementation of project activities in focal communities

Members of the community Surveillance Team still need more capacity building on case management which hampers team's quality of work.

There still exists the prevalence of culture of silence demonstrated by the constant inability of some Stakeholders to speak up against violence perpetrated on women and girls within their communities.

Financial constraints by the communities in effectively prosecuting GBV offenders and implementing some level of activities created in their action plan.

Continuous resistance by some communities who are still hung on certain, practices that subjugate women such as the refusal to work towards discarding the Oro culture in Odogunyan, Ikorodu North LGA of Lagos State.



The Women Voices & Leadership Project aims to contribute to the institutional building of the organization as well as building the capacity and institutionalizing paralegals in communities in the 6 Area councils of the FCT.

FIDA is currently in the second quarter of Year 4 of the 5-year WVL Project.

In the course of the project, FIDA Nigeria has been providing psy-

chosocial support through Reconnect NG to 18 survivors from 6 communities in 4 Area Councils as well as legal representation to 18 survivors from 6 communities in 4 Area Councils in the FCT.

Some of the activities under year 4 includes:

Experiential sharing meeting with paralegals in 2 communities in each of the 3 Area Councils

Project supported by Action Aid, Nigeria for a period of 5 years in FCT, Abuja.



Organize a Coordination meeting with paralegals and communitybased service providers/ responders at the 3 Area Councils

Conduct capacity-building workshops to develop and adopt institutional policies, Human Rights Approach, and other relevant dynamic concepts/tools trending in Gender Based Violence Programming for the FIDA National Secretariat Team

Provide free legal representations for indigent women in the FCT.

Project's Results

Improved institutional mechanisms through the development and operationalization of the strategic plan for the next five years.

Provision of legal services, psychosocial support & referrals for survivors of gender-based violence in three area councils in the Federal Capital Territory, training & retraining of Para-legals amongst others.

At this point, we must reiterate our commitment to improving the safety & security of survivors of GBV through establishing more shelters and safe homes in Nigeria and strengthening the existing Gender Responsive & Protective institutions to be more accountable to the people.





THE SPOTLIGHT INITIATIVE PHASE 2 PROJECT

FIDA Nigeria is currently implementing phase 2 of the Spotlight Initiative Project in six states in Nigeria. In achieving the outcomes of this project, the following interventions are being carried out by FIDA Nigeria:

Building a network of 200 women's and girls' rights advocates and CSOs in Cross River State on gender-responsive budgeting for VAWG/SGBV/HP and advocacy.

cials committing to support the initiatives on gender-responsive budgeting for VAWG/SGBV/HP.

Capacity Strengthening of 10 women's rights and girl's rights advocates and CSOs to have greater knowledge on how to track budget allocation and releases, monitor budget utilization and implementation across relevant ministries.

Organizing review meetings to access the progress of the cohorts in tracking budget allocation and releases as well as monitoring utilization of the budget by the relevant ministries

As an Impact of FIDA Nigeria's advocacy and sensitization activities in Mangun Community, Plateau State, under the Ford Foundation supported project and in furtherance of FIDA's sustainability drive, women and girls of the community independently conducted a massive rally in October, 2021 that conscientize the populace on the harmful practices and socio-cultural norms that subjugate women and girls; and enlightened the populace on the rights of women and girls, as well as the negative effects of SGBV on the health and overall well-being of women and girls.



On the 8th of March 2022, FIDA Nigeria alongside other coalition of women's group protested at the rejection of 5 gender bills by the national assembly had said they would continue to occupy the main gate of the legislative complex until their demands were met.

In a statement by the Country Vice/ National President FIDA Nigeria Amina Suzanah Agbaje,

FIDA Strongly Demands Equal Representation of Women at All Levels of Governance & Leadership in Nigeria: Enjoins Reconsideration of All Gender Responsive Bills Rejected By The Senate.

FIDA strongly demonstrated support for legislative frameworks that supports the rights & attainment of women into leadership positions & other affirmative aspirations. This has been evidenced through her well-known participation at the public hearing forums organized by Joint National Assembly Constitution review committee in the six geo-political zones. FIDA Nigeria's position through her memorandum was on gender affirmative actions and creation of special seats for women at both the National & States Houses of Assembly. We had gone further to eulogise the Joint Committee for taking into consideration our memorandum, upon which the various genderresponsive bills were submitted to both the Senate & Federal Houses of Representatives for ratification.

Despite this giant stride towards promoting gender inclusivity in leadership which we had recorded, we were dismayed on the 1st of March 2022, a date which will always be remembered in our nascent democracy, when most members of the Nigeria Senate at the Senate Chambers voted against the following Gender-responsive Bills submitted for its consideration:

a) Bill No 35. A bill for an act to provide special seats for women in National & State House of Assembly
b) Bill No 37, A Bill for an act to provide for affirmative action in political party administration
c) Bill No 36, A Bill for an act to ex-

pand the scope of citizenship by registration

d) Bill No 38, A bill for an act to provide criteria for qualification to become an indigene of a state in Nigeria.

Based on the majority votes from these members, these gender responsive bills whose beneficiaries are mainly women were rejected. The implication of this rejection indicates there is no proportional representation for women at the parliament, women are denied 35% affirmative action in party administration & leadership positions, denial of affirmative action of women into appointed positions, denial of indigene ship by women of their husband's state after 5 years of being together, denial of citizenship to the foreign-born husband of a Nigerian women amongst others, which has made the struggle for an egalitarian society most inevitable.

a) We urge all like-minded civil society organisations, women led organisations & women's right's organizations to sustain advocacy and intensify demands for Gender equality and opportunities by occupying the National Assembly until the rejected bills are considered b) We call on the Nigeria Senate to as a matter of urgency reconsider consideration of these gender responsive bills

We hope that these sustained advocacy measures will enable the National Assembly in general & the Senate in particular to retract from these patriarchal dispositions towards giving women equal opportunities through reconsideration of these Bills even as we commemorate the International Women's Day on 8th March 2022.
